ORDER U/S 12A(aa) r.w 12(2) OF THE INCOME TAX ACT, 1961

2. Through Finance Act 2007, a new clause i.e(aa) has been inserted in Section 12A along with a new subsection i.e(2), according to which any public charitable trust applying for registration before the competent authority on or after 01.06.2007 will be granted registration subject to satisfaction of the competent authority with reference to the assessment year relevant to the accounting year in which the trust has filed the application.

3. On perusal of the application and its enclosures, it is seen that a genuine trust exists and its activities are being carried out in accordance with the clauses of the trust deed. I am, therefore, satisfied that this trust is entitled to registration to 12A (aa)/12AA of the I.T Act.

3.1 Since in this case, the trust has been created on 26.07.2007 and the application has been filed on 15.12.2008, **the registration will accordingly be effective from 01.04.2008 relevant to Assessment Year 2009-10 and onwards.**
